**CORRIGENDUM**

**Subject: “Filling up the posts of Assistant Advisor (Botany) on Deputation Basis”.**

With reference to the vacancy circular of even No. dated: 04/10/2021 & 24/01/2022 for filling up the post of Assistant Advisor (Botany) of the pay Level 11 with the Pay Band of Rs. 67,700 - 2,08,700 on deputation (including short-term contract basis) in National Medicinal Plants Board, Ministry of Ayush and which was published in the Employment News/Rozgaar Samachar dated: 02nd to 8th October, 2021 & 5th to 11th February, 2022, it is informed that the following clause (a) of the Eligibility Conditions, Experience etc. for filling up of the post of Assistant Advisor (Botany):

*"Officers under the Central/State Govt./ Autonomous/:*

- (i) holding analogous post on a regular basis in the parent cadre/ department' or*
- (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 8,000-13,500 (Revised pay matrix Rs. 53,100-1,67,800 in Level-9 in Seventh Pay Commission) or equivalent in the parent cadre/ department; or*
- (iii) with eight years' service in the grade rendered after appointment thereto on a Rs. 6,500-10,500 (Revised pay matrix Rs. 35,400 - 1,12,400 in Level-6 in Seventh Pay Commission) or equivalent in the parent cadre/department."*

May be read as under

*"Officers under the Central/State Govt./ Autonomous/:*

- (i) holding analogous post on regular basis in the parent cadre/ department' or*
- (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 8,000-13,500 (Revised pay matrix Rs. 56,100 - 1,77,500/- in Level-10 in Seventh Pay Commission) or equivalent in the parent cadre/ department; or*
- (iii) with eight years' service in the grade rendered after appointment thereto on a Rs. 6,500-10,500 (Revised pay matrix Rs. 44,900 - 1,42,400 in Level-7 in Seventh Pay Commission) or equivalent in the parent cadre/department."*

2. All other Terms & Conditions shall remain the same.

3. The applicants may forward their biodata in the prescribed format along with requisite certificates and necessary documents through proper channel as mentioned in the Employment News 02 October- 08 October, 2021 & 5th to 11th February, 2022, within 45 days from the date of the publication of this corrigendum.

4. The Candidates, who have already applied in response to the earlier advertisements for the same post in the Employment News dated: 02nd to 8th October, 2021 & 5th to 11th February, 2022, may re-apply with a fresh copy of the pre-requisite certificates/documents etc in the prescribed format.
