Subject: Removal of Home Herbal Garden (HHG) component from the “Central Sector Scheme for Conservation, Development and Sustainable Management of Medicinal Plants” – reg.

Vide circular of even number dated 05th April, 2021, it has been informed to all concerned that Central Sector Scheme for Conservation, Development and Sustainable Management of Medicinal Plants of NMPB, Ministry of Ayush has been continued beyond 31st March, 2021 for implementation upto FY 2025-26 (copy attached for ready reference).
